- **Condition A:** In any format (printed or electronic); no modification allowed, including to copyright marks. Complete reference should be given.
- **Condition B:** To be linked to the JPSJ and/or JPS Conf. Proc. web page of the relevant article when in electronic format.
- **Condition C:** Transmission to one recipient at a time. Simultaneous transmission to multiple recipients, including mailing list(s), is disallowed.
- **Condition D:** Loading a publisher's version of a PDF file (including a scanned file of the printed version) onto the web server is not permitted. When loading the author's final version, the approval of the co-author(s) is required.
- **Condition E:** The author's final version can be loaded onto the web server only after the article is published online or the printed version is published.
- **Condition F:** Link to the online version of the paper, stating that the copyright is held by The Physical Society of Japan. Provide full citation information, including DOI.

**Remarks**

1. A research project (or project team) composed of members from multiple organizations is regarded as a case of the employer.
2. The terms for printed paper apply to the CD-ROM format and microfilm as well.
3. When reprinting part(s) of an article, such as figures and tables, that include citation(s) or citation information, complete citation information shall be included.
4. Any article that is approved for reproduction/reuse shall be used in deference to copyrights belonging to the (co-)author and the Physical Society of Japan. Further, administration of any article loaded onto the web server is required.
5. These terms shall apply to any requests submitted on/after December 1, 2023.
